# RESIDENTIAL EQUIPMENT

# **Heating Equipment**

To qualify, forced air furnaces and boilers must have an Annual Fuel Utilization Efficiency (AFUE) of 90% or higher. Direct vent space heaters must have an AFUE of 80% or higher. To receive an additional bonus incentive, install a qualifying high efficiency water heater within 30 days of the furnace, boiler or space heater installation.

Furnace	Rating	Rebate
Forced Air Furnace, Boiler	90% min. AFUE	\$200
Direct Vent Space Heater	80% min. AFUE	\$150
Heating & Water Heater Bonus		\$100

## **Programmable Thermostats & Chimney Dampers**

Thermostats must have either 7-day or 5-day/2-day programming along with a change/check filter reminder, and must control the natural gas heating system. Chimney dampers must be installed on a roof top of open wood burning fireplace chimney and MUST be installed by a licensed contractor. No other combustion devices may utilize the chimney.

Rebates cannot exceed measure cost.

### **Water Heaters**

To qualify, the minimum Energy Factor (EF) for 40 gallon tank water heaters must be 0.62, and 50 gallon water heaters must be 0.60. Tankless water heaters must have an Annual Fuel Utilization Efficiency (AFUE) of at least 80%. To receive an additional bonus incentive, install a qualifying high efficiency furnace, boiler or space heater within 30 days of the water heater installation.

# RESIDENTIAL WEATHERIZATION

### It's Wise to Weatherize—Now, More Than Ever!

Substantial cash incentives are available to help pay for improving the energy efficiency of residential homes heated by natural gas from Avista. If the home was built before 1980, the attic, walls or floor may be under-insulated. Avista will also pay up to \$2.25/sf to replace old single-pane windows with more efficient double-pane windows when installed in conjunction with attic, wall or floor insulation. Other weatherization measures available for cash incentives are duct insulation, water pipe insulation, caulking and weather-stripping.





### RESIDENTIAL WEATHERIZATION PROGRAM BASICS:

- BEFORE any work is started a Home Energy Analysis must be completed for the residence. Homeowners should call an Avista representative at 800-227-9187 to request their FREE no-obligation energy analysis.
- The homeowner will be given information explaining program options and cash incentives available to help pay for the costs of weatherizing their home.
- Incentive amounts are calculated after the home energy analysis has been completed.

# **COMMERCIAL INCENTIVES**

# **Commercial High Efficiency Gas Heating**

To qualify, the new natural gas furnace must have an AFUE of at least 91% and a maximum MMBTU of 135. For larger furnaces or boilers, contact Avista for a "site specific" evaluation (see below).

FURNACE	RATING	REBATE
Maximum 135 MMBTU	AFUE minimum 91%	\$200

### Insulation

To qualify, the building being insulated must be heated with natural gas, be no larger than 5000sf and have no more than three floors. If the building does not meet these requirements, please contact Avista and request a "site specific" evaluation (see below). Where practical, the final attic insulation value must be R30, and floors R21. If insulating walls, the wall cavity must be filled.

Attic Insulation	R12 to R19	\$0.29
Attic Insulation	R20 and Above	\$0.17
Wall Insulation	R0	\$0.75

### **Grocery/Retail Refrigeration Night Curtains**

To qualify, natural gas must be the main source of heat. In addition, the refrigeration compressors must be located outside of the heated space.

Coffin Freezer Night Covers	\$5

# **Kitchen Equipment**

Cash incentives are available for fryers, ovens, griddles, steam cookers, and commercial dishwashers. To qualify, natural gas equipment must be purchased new and be either ENERGY STAR® rated or shown in the list of qualifying equipment maintained by Avista. ### **Dishwashers**

To qualify, equipment must be purchased new and be ENERGY STAR rated. A list of qualifying dishwashers can be found at: www.everylittlebit.com

In order to receive an incentive for commercial dishwashers, water must be heated with natural gas from Avista.
